



## Freedom of Information Request Reference N<sup>o</sup>: FOI 003830-18

I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 18 October 2018 which you sought access to the following information:

*“Please can you tell me how many reports of rape or sexual assault you received on each day between August 1, 2018 and Oct 16, 2018? For clarity, please can you break this down to each day?”*

### Response to your Request

The response provided below is correct as of 31 October 2018

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all rape and sexual offences reported to the Constabularies from 1 August – 16 October 2018.

The information provided below confirms the total number of rapes and all other sexual offences reported to the Constabularies during this time frame, by force and day. Please note that the figures relate to crimes reported to either Constabulary on these specific dates, as opposed to the number of offences that have occurred on that date. The data will therefore include historic sexual offences reported to the Constabularies.
