



Freedom of Information Request Reference N°: FOI 003991-18

I write in connection with your request for information received by Suffolk Constabulary on the 29 October 2018 in which you sought access to the following information:

1. *"How many 'domestic abuse related crimes' and 'domestic abuse related Incidents' have your police force recorded in the last three financial years?"*

Please provide separate totals for each of the financial years 17/18, 16/17, 15/16.

2. *How many 'domestic abuse related crimes' and 'domestic abuse related Incidents' have your police force recorded in the last three financial years where the 'victim' and 'suspect' are in a same sex intimate partnership?*

Please provide separate totals for each of the financial years 17/18, 16/17, 15/16."

Response to your Request

The response provided below is correct as of 14 November 2018

Suffolk Constabulary has considered your request for information and the response is below.

In relation to your request for information and in accordance with Section 17 of the Freedom of Information Act 2000 (FOIA), this response serves as a formal notification of refusal for your request. Suffolk Constabulary does not hold, for the purposes of FOIA, the information you require in a retrievable format.

It is estimated that to attempt to retrieve all of the information you require would take a considerable amount of retrieval time, which would exceed 18 hours. This would exceed the appropriate limit for dealing with Freedom of Information requests, in terms of costs and therefore Section 12(1) of the Freedom of Information Act 2000 applies.

Suffolk Constabulary do not record whether or not both parties are in a same sex relationship, although we do record the gender of both the victim and the offender we would have to research each offence to ascertain the relationship, if indeed it has been recoded.

A search was carried out on our crime information system Athena in relation to Domestic Abuse where both parties are of the same sex, this would include those who are in a same sex relationship but it would also include Mother/Daughter, Father/Son, Siblings etc. There were in excess of 4000 crimes between the time periods of 2013 and 2016, this gives you an idea of the



number of cases that would need to be read and would way exceed the statutory time restraints of the FOI Act.

Section 12(1) of the Freedom of Information Act 2000 states that a Public Authority is not obliged to: “...*comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.*” The Freedom of Information (Appropriate Limit and Fees) Regulations, defines the ‘appropriate limit’ for the Suffolk Constabulary as £450 and specifies that this sum equates to 18 hours work at a standard rate of £25 per hour.

In accordance with Section 17(5) of the Freedom of Information Act 2000, this letter serves as a refusal notice for this part of your request.

By requesting *all* information your request is too broad to be complied with within the £450 limit imposed on Freedom of Information requests.

Although excess cost removes the Force’s obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

The number of Domestic Abuse related calls to Suffolk Constabulary is as follows:

2015/16 = 4242

2016/17 = 4294

2017/18 = 4043

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
