I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 1 November 2018 which you sought access to the following information:

1. "How many crimes involving 'wolf whistling' have been reported to your force in 2017? 2018? (I.e. where the term 'wolf whistling' has been mentioned in the MO field of a crime report?)
2. If possible and within the cost limit, of these reported crimes can I find out how many led to convictions?"

Response to your Request

The response provided below is correct as of 6 November 2018

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed of the Constabularies crime system for all offences that contained the words 'wolf whistling' within the crime freetext. Noting that freetext searches are by their very nature, unreliable, and there may be additional relevant offences that have not been located owing to this specific phrase not being present.

There were a total of 6 Norfolk offences located, all in 2017.

There were no offences located for Suffolk Constabulary.

The Constabularies do not hold conviction data and we have therefore provided the recorded outcome as an alternative.

Outcome	2017
Type 16 – Named suspect identified – Evidential difficulties	5
Type 8 – Community resolution	1

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may

receive.
