I write in connection with your request for information received by Suffolk Constabulary on the 29 November 2019 in which you sought access to the following information:

“Under the Freedom of Information Act, please could you provide the following information for each crime report where the summary includes the phrase "go back to" or "go home" - month and year of the report, offence type, hate crime flag, if applicable, and outcome. Please provide this information for the period from July 1, 2014 to June 30, 2019”

Response to your Request

The response provided below is correct as of 29 November 2019

Suffolk Constabulary has considered your request for information and the response is below.

The information provided within the attached spreadsheet confirms all offences recorded where the terms 'go back to' or 'go home' are recorded within the crime freetext. The information supplied includes the month and year of the report, the relevant phrase included, the offence classification, whether or not it is a hate crime and the respective outcome.

Please note that the information supplied does not confirm the details of the above phrases and we therefore cannot confirm the context by which they were used.

Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.

Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
