The response provided below is correct as of 30 December 2019

Suffolk Constabulary has considered your request for information and the response is below.

It is routine practice for a safeguarding referral to be made to Children’s Social Care for each application made under the Child Sex Offender Disclosure Scheme.

The total number of applications made to Suffolk Constabulary under the Child Sex Offender Disclosure Scheme (CSODS) from the date the Scheme was launched in the Constabulary (August 2010), is as follows:

Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
