I write in connection with your request for information received by Suffolk Constabulary on the 3 October 2017 in which you sought access to the following information:

*“How many crimes has your force recorded during each of the following financial years where the location of the crime was a bookmakers shop?”*

2014/15  
2015/16  
2016/17

*For each year please provide a breakdown of each crime stating i) the type of crime ii) a summary of the MO and/or circumstances iii) the outcome of the investigation”*

**Response to your Request**

The response provided below is correct as of 3 October 2017

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary’s crime system for all offences recorded that relate to a betting shop. The Constabulary does not have a marker or flag on the crime system specifically identifying a betting shop and we have therefore searched on the following locations:

- Betfred
- Coral
- William Hill
- Bradfields (sports bookmakers)
- Jennings bet
- Ladbrokes
- Paddy power
- The winning post
- Firstbet

The tables provided within the attached spreadsheet confirm the total number of offences recorded at, or in the vicinity of, the above locations.

***Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.***

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
