## **Freedom of Information Request Reference N<sup>o</sup>: FOI 006797/17**

I write in connection with your request for information received by the Norfolk and Suffolk Constabulary on the 11<sup>th</sup> October 2017 in which you sought access to the following information:

How many health and safety incidents have been logged at your organisation in the last two years (2015/16 and 2016/17)?

Please provide the details of what happened in each incident and what action was taken.

"Health and safety incidents" being defined as an incident which has resulted in someone being injured or nearly injured while at your organisation.

### **Response to your Request**

When responding to a request for information under the terms of the Freedom of Information Act, a public authority is not obliged to provide information if the authority estimates that the cost of the retrieval of the information requested would be in excess of £450 (equivalent to 18 hours work).

The costs criteria relates to a request in its entirety, which means that if we cannot retrieve all of the information requested within the costs limit, we are not obliged to retrieve *any* of the information requested.

The Norfolk and Suffolk Constabularies estimates that to retrieve all the information you have requested for both forces would exceed cost in excess of £450 (per force).

The Workplace Health, Safety and Wellbeing Department collates details of Health & Safety incidents and near misses. Whilst this provides some of the requested information, the details of any action taken, is not centrally recorded. Therefore in order to provide you with all of the requested information, it would be necessary to review each recorded incident or near miss to see if any follow up action was taken. Due to the number of records, to carry out this research would significantly exceed 18 hours for each Constabulary.

This would exceed the appropriate limit for dealing with a Freedom of Information request, in terms of costs, and therefore Section 12(1) of the Freedom of Information Act applies.

Section 12(1) of the Freedom of Information Act states that a public authority is not obliged to:

*"...comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit".*

The Freedom of Information (Appropriate Limit and Fees) Regulations 2004, defines the 'appropriate limit' for the Norfolk and Suffolk Constabularies as £450 for each Constabulary, and specifies that this sum equates to 18 hours work at a standard rate of £25 per hour.

In accordance with Section 17 of the Freedom of Information Act (2000), this serves as a Refusal Notice for your request.

#### Advice and Assistance

Although excess cost removes Norfolk and Suffolk Constabularies obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relevant to your request, which was retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

Please see attached spreadsheets which detail the number of incidents, broken down by location, duty being performed and severity.

Ask Norfolk and Suffolk Constabularies to look at the decision again.

If you are dissatisfied with the decision made by Norfolk and Suffolk Constabularies under the Freedom of Information Act (2000), regarding access to information, you must notify the Norfolk and Suffolk Constabulary that you are requesting a review within 20 days of the date of its response to your Freedom of Information request.
