## **Freedom of Information Request Reference N°: FOI 002032-19**

I write in connection with your request for information received by Suffolk Constabulary on the 30 May 2019 in which you sought access to the following information:

*“Crimes reported by crime type where the venue of the crime is a hotel or hotel car park (not guest house or hostel) for 2014-15 / 2015-16 / 2016 -17/ 2017-18 / 2018-19.”*

### **Response to your Request**

The response provided below is correct as of 19 June 2019

Suffolk Constabulary has considered your request for information and the response is below.

A search has been completed of the Constabulary's crime system for all offences recorded where the location premise description is recorded as 'Hotel'.

Please note that the current crime system, which contains information from 19 October onwards only has a property descriptor of 'Hotel/B&B/Guest House' and therefore the information for this time frame will contain offences that also relate to B&Bs and Guest houses, this information can't be broken down without manually reviewing each offence and then cross referencing the location with external sources to establish whether it is a hotel or otherwise.

Information held prior to 19 October 2015 has a location type of 'Hotel'.

The information provided on the attached spreadsheet confirms the total number of offences recorded using the above search parameters, noting that information provided cannot be compared year on year owing to the change in crime recording during October 2015.

***Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this force's response to your questions should not be used for comparison purposes with any other response you may receive.***

Your Right to Request a Review of Decisions Made Under the Terms of the  
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
