I write in connection with your request for information received by Suffolk and Norfolk Constabularies on 17 June 2020 which you sought access to the following information:

“Please may I request information regarding to ALL Speeding Offences captured by your force in your area of authority.

This information will go back to 5 years to current date of you processing this request.

To confirm the format: to be broken down day by day.

Date of offence – Workflow Status – offence type name – location – Fine – course status – court status – number of offences – Camera Type description

If it is possible, can the offence type be broken down further as either sp30/sp40 etc etc”

Response to your Request

The response provided below is correct as of 26 June 2020

Suffolk and Norfolk Constabularies have considered your request for information and the response is below.

A search has been completed by the Constabularies Central Ticket Office for all speeding offences recorded for the years 2016 - 2020 (to date).

The information provided within the two excel spreadsheets confirm the total number of speeding offences recorded as of the date of the request. The information recorded within the system is not in the same way as requested, we have therefore supplied data in the following fields:

- Offence Date
- Offence Description
- Location Street and Town
- Camera description
- Notice status (workflow status)
- Disposal completion method

The Constabularies do not know the outcome of fines issued by the courts however, the disposal method will identify those that went through the court process.

The system does not identify whether the offence was sp30/40 etc, as those are endorsement codes decided by the DVLA.
