4. *Are you looking at a move to Infrastructure Cloud within the next 24 months?”*

Response to your Request

The response provided below is correct as of 10 September 2020

Suffolk Constabulary has considered your request for information and the response is below.

1. Suffolk Constabulary has many support contracts with a number of suppliers to both Support and Maintain our systems. All of the relevant contracts are available on the Blue Light Procurement Database:

Section 17 of the Freedom of Information Act 2000 requires that Suffolk Constabulary, when refusing to provide such information (because the information is exempt) is to provide you the applicant with a notice which:

- (a) States that fact
- (b) Specifies the exemption(s) in question and
- (c) States (if that would not otherwise be apparent) why the exemption(s) applies.

The information is exempt from disclosure by virtue of the following exemption(s);

Section 21(1) - Information reasonably accessible by other means

The contracts are all published on the Blue Light Procurement Database and can be found via the following link. The information can be filtered for Suffolk Constabulary and searched using relevant keywords to locate the contracts associated with the managed service.

Your Right to Request a Review of Decisions Made Under the Terms of the
Freedom of Information Act (2000).

If you are unhappy with how your request has been handled, or if you think the decision is incorrect, you have the right to ask Suffolk Constabulary to review their decision.

Ask Suffolk Constabulary to look at the decision again.

If you are dissatisfied with the decision made by Suffolk Constabulary under the Freedom of Information Act (2000), regarding access to information, you must notify Suffolk Constabulary that you are requesting a review within 40 working days of the date of its response to your Freedom of Information request.
